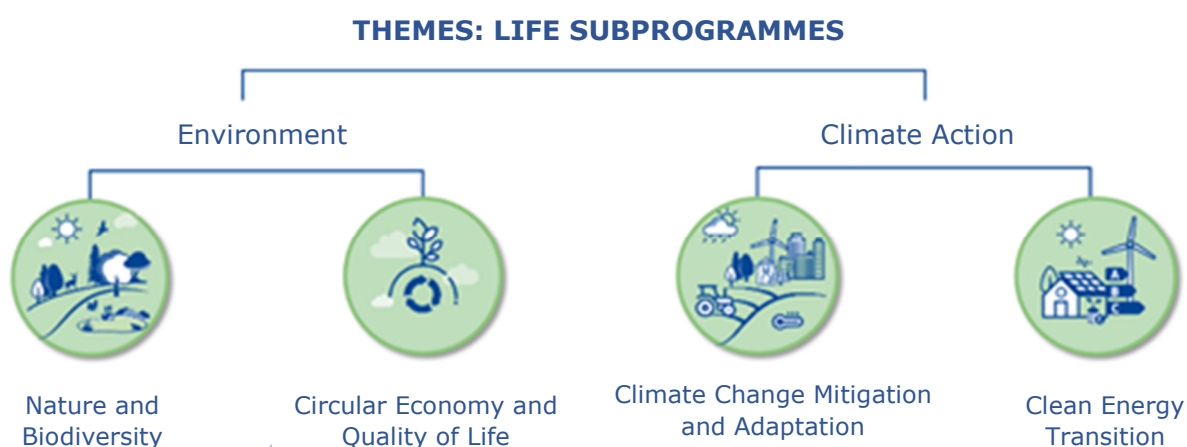

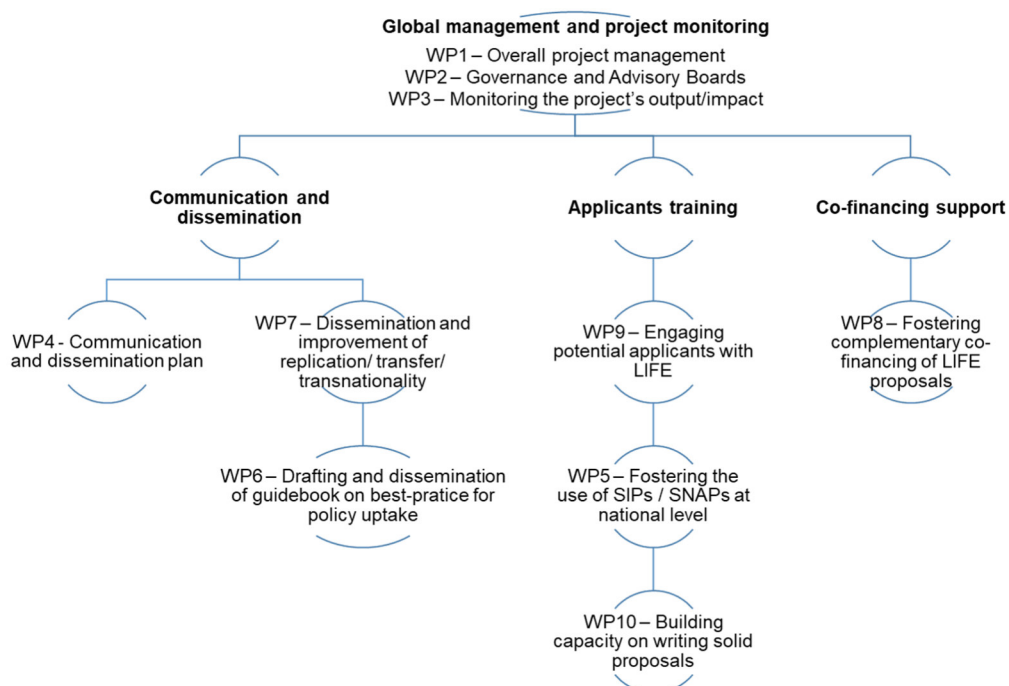
# Goals

The project's specific objectives are:

- Improve and foster good governance through stakeholder involvement, thereby seeking to integrate external input and technical advice and leverage the support provided;
- Promote the communication and dissemination of LIFE Programme and its projects;
- Involve potential beneficiaries through critical and timely discussion of project ideas and their suitability for LIFE, promoting a "LIFE community" well prepared for the establishment of partnerships and consortia;
- Provide applicants with targeted support for the preparation of stronger proposals in all sub-programmes;
- Improve the design of the project with regard to its replication, transfer and transnationality;
- Increase the number of Strategic Integrated Projects (SIP) and Strategic Nature Projects (SNAP) promoted by Portuguese authorities;
- Enhance the influence and adoption of project results in current policies, based on the positive experience of other projects;
- Facilitate contacts between LIFE applicants and potential co-financiers to ensure complementary co-financing to the LIFE Programme.
